

## SUMMER VILLAGE OF KAPASIWIN

### BYLAW #278-2024

**BEING A BYLAW TO AUTHORIZE THE RATES OF TAXATION AGAINST ASSESSABLE PROPERTY WITHIN THE SUMMER VILLAGE OF KAPASIWIN IN THE PROVINCE OF ALBERTA FOR THE 2024 TAXATION YEAR.**

**WHEREAS** the Summer Village of Kapasiwin has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on May 9, 2024; and

**WHEREAS** the estimated municipal expenditure and transfers set out in the budget (excluding non-cash items) for the Summer Village of Kapasiwin for 2024 total \$258,228.00; and

**WHEREAS** the estimated municipal revenues and transfers from all sources other than taxation are estimated at \$165,194.00; and

**WHEREAS** \$93,034 is to be raised by general municipal taxation; and

**WHEREAS**, the requisitions are:

**WHEREAS**, the Council of the Summer Village of Kapasiwin is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

**WHEREAS**, the Council is authorized to classify assessed property, and to establish different rates of taxation with respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Status of Alberta, 2000; and

**WHEREAS**, the assessed value of all property in the Summer Village of Kapasiwin as shown on the assessment roll is:

**NOW THEREFORE**, under the authority of the Municipal Government Act, the Council of the Summer Village of Kapasiwin, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Summer Village of Kapasiwin:
